Planning and Environment Act 1987 WANGARATTA PLANNING SCHEME Notice of the preparation of Amendment C68

The Wangaratta Rural City Council has prepared Amendment C68 to the Wangaratta Planning Scheme.

The land affected by the amendment is the Milawa Township and immediate surrounds.

The amendment proposes to implement the key objectives immediate and ongoing actions and short term actions of the *Milawa Township Development Plan, September 2015* into the Wangaratta Planning Scheme by; amending the Local Planning Policy Framework to include the *Milawa Township Development Plan, September 2015*, amending the Schedule to the Low Density Residential Zone and rezoning land in accordance with the *Milawa Township Development Plan, September 2015*.

You may inspect the amendment, any documents that support the amendment and the explanatory report about the amendment, free of charge, at the following locations:

Any person who may be affected by the amendment may make a submission to the planning authority about the amendment. Submissions must be made in writing giving the submitter's name and contact address, clearly stating the grounds on which the amendment is supported or opposed and indicating what changes (if any) the submitter wishes to make.

Name and contact details of submitters are required for council to consider submissions and to notify such persons of the opportunity to attend council meetings and any public hearing held to consider submissions. The closing date for submissions is Friday 21 April, 2017.
