New owners please be aware of the following:

Requirements under the Domestic Animals Act 1994

All cats and dogs three months of age or older must be registered. All new registered animals must be microchipped. Failure to register your cat or dog (or to renew their registration on or before 10 April each year) will make you liable for an infringement notice. A child's cat or dog must be registered in the parent or guardian's name.

Impounding of cats and dogs

Dogs or Cats found wandering at large may be impounded. A release fee plus costs and registration fee, if unregistered, must be paid before release from the pound. Infringements may also be issued by Council for unregistered Dogs / Cats and for dogs found wandering at large.

Allowable number of animals

As per Local Law No.1 of 2018 no more than 2 dogs and 2 cats are allowed per residential or commercial area without an Excess Animal Permit. Please request an Excess Animal Application if this applies to you.

1 - Restricted Breeds

Restricted breeds are as follows: Pitbull Terrier, American Pitbull Terrier, Fila Brasileiro, Dogo Argentino, Japanese Tosa or Perro de Presa Canario.

Please contact a Community Compliance Officer on 5722 0888 if you wish to transfer ownership of animals which are of a restricted breed, or that have been declared menacing or dangerous.
